1. Audit

We will audit your current analytical environment:

- Software version level
- Operating system version level, if supported by Teradata
- Version levels of Teradata clients and utilities
- Hardware firmware levels, if supported by Teradata

2. Assessment

Teradata will identify the optimal migration path:

- Prepare download packages and spool packages
 - Any impacts to your current environment, including software compatibilities and interactions
 - Customer and site specific software load packages needed for a successful software change

3. Change Control Plan

We will develop a change plan outlining the optimal migration path:

- Estimate timeframes and sequence of events
- Identify product and technical dependencies
- Identify roles and responsibilities
- Outline data back-up and conversion plan
- Conduct formal change control meeting to gain approval

4. Platform Upgrade

As part of the platform upgrade, Teradata will:

- Perform a system validation
- Convert data, as applicable
- Upgrade the various Teradata and OS software packages, if supported by Teradata
